ARTICLES OF INCORPORATION OF COLUMBIA WEST MEDIA GROUP, INCURPORATES

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

Article I Corporate Name

The name of this corporation is: Columbia West Media Group, Incorporated

Article II Corporate Existence

The corporate existence of this corporation shall be perpetual.

Article III Purposes

This corporation is organized for purposes of transacting any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

Article IV Authorized Capital

The aggregate number of shares which this corporation shall have authority to issue is one million (1,000,000) shares of a single class of Common Stock at an initial par value of one dollar (\$1.00) per share, or such par value as may be fixed by the Board of Directors. All stock shall be non-assessable.

Article V Denial of Preemptive Rights

This corporation shall make no provision for the denial of preemptive rights.
