**ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

**Article I
Corporate Name**

The name of this corporation is: Columbia West Media Group, Incorporated

**Article II
Corporate Existence**

The corporate existence of this corporation shall be perpetual.

**Article III
Purposes**

This corporation is organized for purposes of transacting any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

**Article IV
Authorized Capital**

The aggregate number of shares which this corporation shall have authority to issue is one million (1,000,000) shares of a single class of Common Stock at an initial par value of one dollar (\$1.00) per share, or such par value as may be fixed by the Board of Directors. All stock shall be non-assessable.

**Article V
Denial of Preemptive Rights**

This corporation shall make no provision for the denial of preemptive rights.

**Article VI
Governance of Internal Affairs**

The internal affairs of this corporation shall be governed by the corporation bylaws in a manner not inconsistent with the provisions of these Articles of Incorporation.

**Article VII
Registered Office and Registered Agent**

The address of the initial registered office of this corporation is 264 West Boise Avenue, Boise, Idaho 83702, and the name of the initial registered agent at such address is Cynthia A. Randall.

**Article VIII
Board of Directors**

The Board of Directors shall consist of at least two (2) and not more than nine (9) members, as may be determined from time to time by the bylaws of this corporation. 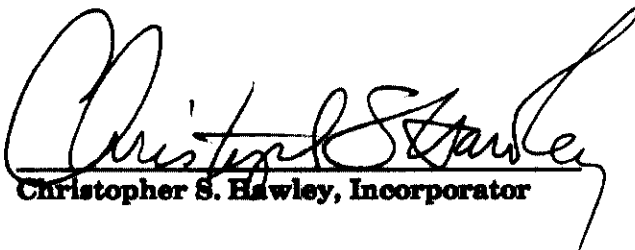
