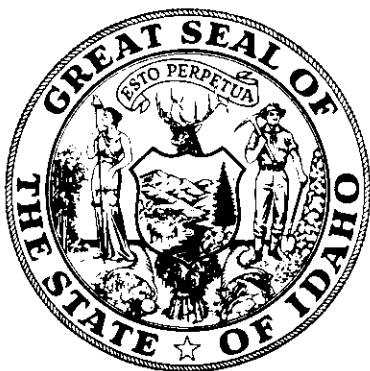

CERTIFICATE OF INCORPORATION
OF

FIRST

The name of this corporation is Pocatello Area Square and Round Dance Assn. Inc.

SECOND

Its initial registered office in the state of Idaho is to be located at 1100 Booth Road, in the City of Pocatello, County of Bannock.

THIRD

The initial registered Agent is Lloyd E. Lycan, 1100 Booth Road, Pocatello, ID 83201.

FOURTH

The nature of the business to be - the transaction of any or all lawful business for which corporations may be incorporated under this Act.

FIFTH

The duration of said corporation will be perpetual.

SIXTH

The amount of the total authorized capital stock of this corporation is 1000 shares of \$100.00 par value, which includes 500 shares designated "A" series issued for cash subscriptions and 500 shares designated "B" series issued for services, labor, and or materials. Both "A" and "B" series will have a par value of \$100.00 and equal voting rights.

SEVENTH

All of the corporation's issued stock, exclusive of treasury shares, shall be held of record by not more than five hundred (500) persons.

EIGHTH

Each stockholder shall offer to the corporation or to other stockholders of the corporation a ninety (90 day) first refusal option to purchase his stock should he elect to sell stock.

NINETH

The corporation shall make no offering of any of its stock of any class which would constitute a "public offering" within the meaning of the United States Securities Act of 1933, as it may be amended from time to time.

TENTH

ELEVENTH
