2 making stock dividends to its shareholders, and to restrict
3 the transferability of its outstanding shares to the extent
4 reasonably necessary to protect the rights of the corpor-
5 ation and its shareholders in any stock purchase, contracts,
6 or options that may be made between themselves or any of
7 them.

8 (5) To act as surety or creditor in any and all types
9 of engagement including the power to execute, endorse and
10 deliver contracts and to guarantee the prompt and faithful
11 performance for payment of debts, notes, agreements, con-
12 tracts and undertakings of any other person, firm, partner-
13 ship or corporation, and to act as accomodation co-maker or
14 guarantor on obligations either as primary or secondary
15 obligor.

16 (6) Without in any manner limiting any of the objects,
17 purposes or powers of the corporation, the business or pur-
18 poses of said corporation shall be from time to time to do any
19 of one or more or all of the acts or things herein set forth.

20 (7) The several subdivisions contained in this para-
21 graph of purposes shall be construed as both purposes and
22 powers and the enumeration thereof shall not be held to
23 limit or restrict in any manner the general powers con-
24 ferred on business corporations by the laws of the State of
25 Idaho, all of which powers are hereby expressly claimed.
