

Certificate of Incorporation of the  
Weston Irrigation Company, a Corpora-  
tion formed for the purposes herein-  
after expressed.

Article 1<sup>st</sup>. The corporate name of this  
corporation is, and shall be  
the "Weston Irrigation Company".

Article 2<sup>d</sup>. The principal place of  
business of said corporation is  
intended to be within the County  
of Oneida in the Territory of Idaho,  
and the principal office and place  
of business of said corporation shall  
be the town of Weston in said  
County of Oneida.

Article 3<sup>d</sup>. The objects for which this  
Corporation is formed are  
to take, appropriate, hold, own and  
convey from about the mouth of  
Weston Canon to Bear River on  
either or both sides of Weston Creek,  
and dispose of for irrigation or other

purposes, the waters of Weston Creek,  
and its tributaries in the County of  
Winnebago and Territory of Idaho,  
and so that end, and for said purposes,  
to acquire by purchase or other legal  
means and hold, own and have the  
sole use of the necessary right of way  
for all ditches, aqueducts, flumes  
and other structures and means  
requisite and proper for said  
business of said Corporation, and  
to do and perform generally all  
acts and things necessary to be  
done for the successful carrying on  
of the business aforesaid of said  
Corporation,

Article 4. The amount of the capital  
stock of said Corporation is  
and shall be, the sum of Five  
Thousand dollars, and the same  
shall be divided into ~~two~~ <sup>two hundred</sup>  
shares of Twenty five dollars each.

Article 5. This Corporation shall

continue for the period of Fifty-  
years from the Sixth day of July  
A. D. 1875.

Article 6. There shall be Five  
Trustees of this Corporation,  
who shall manage the concerns of  
the said Corporation for the first three  
months after the formation thereof;  
the names and residences of said  
first Trustees are as follows:
