2 we, the undersigned, have this day
3 voluntarily associated ourselves together
4 for the purpose of forming a Corporation
5 under the laws of the State of Idaho,
6 And we do hereby certify, —

7 — First, That the name of our said
8 Corporation is Then Allen and Gibson
9 Loan & Investment Company, —

10 — Second. That the purposes for which it is
11 formed are to carry on the business of
12 buying and selling real estate and per-
13 sonal property, commercial paper, school,
14 municipal and other bonds, and securities,
15 both public and private. To loan on
16 borrow money, and to receive on issue
17 notes, bonds, mortgages on debentures for
18 the same. To construct buildings and to
19 rent, lease and control the same. To lay
20 out, plat and improve town sites, on other
21 lands, to construct canals, water-works,
22 artesian wells, electric light, gas on other
23 illuminating plants, telephone and street-
24 car service, and to transact a general
25 investment, real estate, loan and
26 insurance business, with full authority
27 to do all things that may be necessary
28 for promoting and carrying out the objects
