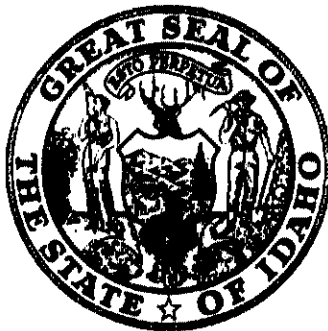
CERTIFICATE OF INCORPORATION OF

ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation under the Idaho Professional Services Corporation Act and the Idaho business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is:

V. DEAN DALLING, P.A.

SECOND: The period of its duration is perpetual.

THIRD: The purpose for which the corporation is organized is to provide professional services in the practice of law, allied professional services, and all other purposes allowed by the laws of the State of Idaho.

FOURTH: The aggregate number of shares which the corporation has authority to issue is fifty (50) shares of common stock, all of one class, without par value.
