NEZ PERCE FARMERS' COUNTY MUTUAL FIRE INSURANCE COMPANY  
AND SECRETARY OF STATE  
IDAHO FARMERS COUNTY MUTUAL FIRE INSURANCE COMPANY STATE OF IDAHO

## I.

The Agreement and Plan of merger (hereinafter "Plan of Merger") attached hereto as Exhibit "A" and incorporated herein by reference, has been approved by the Board of Directors and by the policyholders of Idaho Farmers County Mutual Fire Insurance Company, the merged insurer, and has been approved by the Board of Directors and by the policyholders of Nez Perce Farmers' County Mutual Fire Insurance Company, the surviving insurer.

## II.

(a) The Agreement and Plan of Merger was approved by the Board of Directors of Nez Perce Farmers' County Mutual Fire Insurance Company at its home office in Kendrick, Idaho on the 5<sup>th</sup> day of August, 2003.

(b) The Agreement and Plan of Merger was approved by the Board of Directors of Idaho Farmers County Mutual Fire Insurance Company at its home office in Cottonwood, Idaho on the 9<sup>th</sup> day of May, 2003.

## III.

The surviving mutual insurer in this merger is Nez Perce Farmers' County Mutual Fire Insurance Company, a mutual insurer organized under the laws of the State of Idaho. Idaho Farmers County Mutual Fire Insurance Company is fully merged into the surviving insurer. Said surviving mutual insurance company is authorized to engage in the business of insurance in Idaho.

## IV.

Pursuant to *Idaho Code Section 30-1-73* and *Idaho Code Section 41-2857, et seq.*, the surviving mutual insurance company shall be continued under the name of Nez Perce Farmers' County Mutual Fire Insurance Company (hereinafter referred to as "surviving insurer").

## V.

The affirmative vote of two-thirds of all votes cast by policyholders present or represented by written proxy of the Idaho Farmers County Mutual Fire Insurance Company policyholders is required to adopt the Plan of Merger. There are 368 outstanding policies of Idaho Farmers County Mutual Fire Insurance Company and each policyholder is entitled to one

vote. The policyholders meeting was held at 1:00 p.m. on the 23<sup>rd</sup> day of May, 2003, at the home office of Idaho Farmers County Mutual Fire Insurance Company, Cottonwood, Idaho, pursuant to notice. On the date of the Idaho Farmers County Mutual Fire Insurance Company policyholders meeting, there were 114 policyholders present and entitled to vote either in person or by written proxy and the plan of merger was adopted by a vote of 104 for and 10 against, said affirmative vote being ninety-one percent (91%) of the policyholders voting thereon.

The affirmative vote of two-thirds of all votes cast by policyholders present or represented by written proxy of the Nez Perce Farmers' County Mutual Fire Insurance Company policyholders is required to adopt the Plan of Merger. There are 309 outstanding policies of Nez Perce Farmers' County Mutual Fire Insurance Company and each policyholder is entitled to one vote. The policyholders meeting was held at 5:00 p.m. on the 13<sup>th</sup> day of June, 2003, at the home office of Nez Perce Farmers' County Mutual Fire Insurance Company, Kendrick, Idaho, pursuant to notice. On the date of the Nez Perce Farmers' County Mutual Fire Insurance Company policyholders meeting, there were 54 policyholders present and entitled to vote either in person or by written proxy and the plan of merger was adopted by a vote of 51 for and 3 against, said affirmative vote being ninety-four percent (94%) of the policyholders voting thereon.

## VI.

The Directors of the Surviving insurer, Nez Perce Farmers' County Mutual Fire Insurance Company are and shall be the following:


VIII.





**EXHIBIT "A"**

**PLAN OF MERGER**

**Section I**

File Assumption by Merger Certificate with Idaho Insurance Department (copy attached).

**Section II**

Each policy holder of Idaho Farmers' County will be furnished with an Assumption by Merger Certificate.

**Section III**

The Idaho Farmers' County policyholders will be serviced by agents/directors similar as before, as requested by Idaho Farmers' County Board of Directors.

Nez Perce Farmers' County Mutual will manually operate from a log of all policyholders of Idaho Farmers' County showing name, coverage, due dates, etc., as each policy comes due for renewal, it will be given a new number and placed in Nez Perce Farmers' County regular data processing system. We believe this procedure will insure that all Idaho Farmers' County policyholders will receive prompt and fair service.

**Section IV**

All existing insurance policies issued by Idaho Farmers' which are for commercial coverages that Nez Perce Farmers' does not write will be cancelled effective prior to the effective date of the merger. All existing insurance policies issued by Idaho Farmers' which provide coverages at an amount in excess of \$175,000.00 shall be cancelled effective prior to the effective date of the merger. All existing insurance policies issued by Idaho Farmers' which may have been issued for insurable assets which are substantially under insured shall be cancelled effective prior to the effective date of the merger.

**Section V**

All remaining Idaho Farmers' policyholders (exclusive of the policyholders whose policies are cancelled in Section IV above), by Assumption Certificate will be accepted by Nez Perce Farmers' County Mutual as written. We will anticipate that the servicing agency will inspect and rewrite risk at policy renewal date or at policyholder request prior to renewal date.

**Section VI**

Prior to approval of the merger by the Idaho Department of Insurance, Nez Perce Farmers' County Mutual Fire Insurance Company will examine the books of Idaho Farmers' County Mutual Fire Insurance Company, review the claims register, and make current claims inquiry of Idaho Farmers' reinsurance carrier, all for the purpose of satisfying Nez Perce Farmers' County Mutual Fire Insurance Company, in its discretion and determination that the merger transaction is beneficial to Nez Perce Farmers' County Mutual Fire Insurance Company policyholders.

**Section VII**

Upon completion of merger considerations, all assets of Idaho Farmers' County Mutual Fire Insurance Company will be transferred to Nez Perce Farmers' County Mutual Fire Insurance Company.


