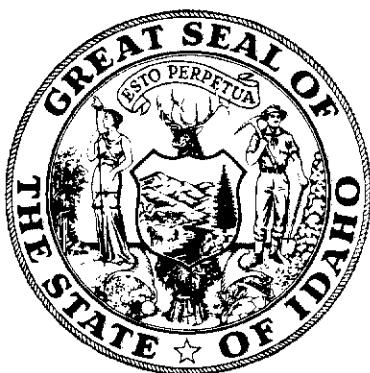

Articles of Amendment to the Articles of Incorporation of

5. The number of shares voted for and against said amendment, respectively were as follows:


