- 2. That the true and correct spelling of the name of Charles G. Hanson, 1315-12th Avenue South, Nampa, Idaho, one of the four incorporators, is Charles G. Hanson, rather than Charles G. Hansen, as appears throughout the original Articles of Incorporation of Garde, Incorporated of Nampa.
