

PURSUANT to the provisions of Section 30-1-59 of the Idaho Business Corporation Act, the undersigned Association adopts the following Articles of Amendment to its Articles of Incorporation:

First: The name of the Corporation is **E. MONTE CRANDALL, M.D., A PROFESSIONAL ASSOCIATION.**

Second: The following amendment of the Articles of Incorporation was adopted by the shareholders of the Association on the 20th day of February, 1990, in the manner prescribed by the Idaho Business Corporation Act:

ARTICLE I

Name of Association


