

Articles of Incorporation of The D & C Lateral Ditch Company Ltd.

FIRST.

The name of the Corporation hereby organized is "The D & C Lateral Ditch Company Ltd.

SECOND.

The purpose for which said corporation is formed is the purchase, owning and holding of water for irrigation or other beneficial use; the renting or sale thereof to others for irrigation or other beneficial use; the construction and use of ditches, flumes, canals and reservoirs for the passage, distribution and holding of water to be used for irrigation or other beneficial use.

THIRD.

The place where the principal business of the said corporation is to be transacted, and its principal office kept, is at Emmett Canyon County, State of Idaho.

FOURTH.

The term for which the said corporation is to exist, is Thirty years.

Fifth.

The number of the Directors of said Corporation shall be five, who must be stockholders of the corporation.

SIXTH.

The amount of the capital stock of said corporation shall be FIVE THOUSAND dollars, and said capital stock shall be divided into TWO HUNDRED shares of the par value of Twenty five dollars for each share.
