ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS: 16 AM 8: 37

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, citizens of the United States of America, at Ever the America per ghteen years, have this day voluntarily associated ourselves Tagether for the purpose of forming a corporation under the laws of the State of Idaho, and we certify in writing:

That the name of the corporation shall be PATTICO, INC.

II.

That the purpose for which said corporation is formed is to engage in the operation of a business services using a style, system, and method of operation to be developed by the officers and stockholders of the corporation or other persons; to sell or purchase its own stock, or to sell and purchase the corporate stock of any other corporation; to take, own, and hold mortgages, trust deeds or other liens; to own real and personal property and to dispose of same in any manner that may be necessary for the benefit of said corporation; to enter into, make and perform contracts of every kind and with any person, firm, association or coporation, municipality, State Government or colony or dependency thereof, and without limit as to amount; to draw, make, accept, endorse, discount, execute and issue promissory notes, drafts, bills of exchange, bills of sale, bulk sale, bulk sales agreements, warrants and other negotiable or transferable instruments, and to secure the same by mortgage, trust deed, chattel or otherwise, so far as may be permitted by laws of the State of Idaho, and to do all things necessary and covenient in carrying out the purposes for which this corporation is organized, and especially to exercise all of the powers and rights granted to general business corporations under the laws of the State of Idaho pertaining thereto at the date of the issuance of a certificate of incorporation to these incorporators.

III.

That the term for which said corporation is to exist is perpetual.

That the principal office and place of business of said corporation is the City of Pocatello, County of Bannock, State of Idaho.

V

That the number of directors of said corporation shall be not less than two (2), nor more than five (5).

VI.

That the President and Secretary-Treasurer of the corporation shall be employed to execute in behalf of the corporation all necessary applications for such permits as may be required under Federal, State or local laws.

VII.

That the amount of total authorized capital stock is \$10,000.00; of said stock, the entire authorization shall be 100 shares common stock of the par value of \$100.00 per share.
