KNOW ALL MEN BY THESE PRESENTS: That the following amendments to the Articles of Incorporation of the above named corporation are hereby adopted.

- 1. The name of the corporation is LASER MAGIC RESEARCH AND DEVELOPMENT CORPORATION.
- 2. Article VI of the Articles of Incorporation is hereby amended to provide that the par value of each of the 100,000 shares of the authorized capital stock of this corporation shall be Ten Cents (\$.10).
- 3. The above amendment was adopted by unanimous consent of all the shareholders of the corporation in the absence of a meeting on April 21, 1986.
- 4. The number of shares outstanding and the number of shares entitled to vote thereon is 25,000.
  - 5. The number of shares voting for such amendment is 25,000.
