

# **Articles of Incorporation**

The undersigned, in order to form a Non-Profit Corporation under the provisions of Title 30, Chapter 3, Idaho Code, submits the following articles of incorporation to the Secretary of State.

## **Article I Name**

The name of the corporation shall be Moriah Rain Ministries, Inc.

## **Article II Purpose**

The specific purpose for which the corporation is initially organized is to be a ministry to the people of Israel, bringing comfort through prayer, practical support, raising public awareness and educational programs, to teach and preach the gospel through speaking engagements at religious venues, to produce and distribute Christian literature, to conduct public evangelistic activities, to offer bible based classes, to provide spiritual counseling, to license, ordain and oversee ministers of the gospel and to also engage in activities which are necessary, suitable or convenient for the accomplishment of that purpose, or which are incidental thereto or connected therewith which are consistent with Section 501(c)(3) of the Internal Revenue Code. **This corporation is organized and operated exclusively for religious purposes within the meaning of Section 501(c)(3), Internal Revenue Code.**

## **Article III Registered Office And Agent**

The street address of the registered office is 2745 E Sand Trap Way, Post Falls, ID 83854 and registered agent at such address is Donald Michael Giannini.

## **Article IV Directors**

This corporation shall have not less than two (2) nor more than nine (9) directors. The initial directors whose positions and duties are set forth in the bylaws will manage the affairs of this corporation. The names of the initial directors who are to serve are as follows:

## **Article VII Membership**

The corporation does not have voting members.

## **Article VIII Term And Dissolution**

The term of this corporation shall be perpetual. In the event of dissolution of the corporation, no part of the corporation's earnings or assets shall inure to the benefit of any of its members; the residual assets of the corporation shall be distributed to one or more organizations which themselves are exempt as organizations described in Sections 501(c) (3) and 170(c) of the Internal Revenue code of 1986, or corresponding sections of any prior or future law, or to the federal, state or local government for exclusive public purpose.

## **Article IX Additional Provisions**

No part of the net earnings of the corporation shall ever inure to the benefit of, or be distributable to its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article II. No substantial part of the activities of the corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on: (a) by a corporation exempt from Federal Income Tax under Section 501(C)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law or: (b) by a corporation, contributions to which are deductible under Section 170(C) of the Internal Revenue Code of 1986 or the corresponding provisions of any future United States Internal Revenue laws.
