ARTICLES OF INCORPORATION  
OF  
WESTVIEW GUERNSEY DAIRY, INC.

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, being natural persons of legal age, and citizens of the United States and bona fide residents of the State of Idaho, do hereby associate ourselves together for the purpose of forming a corporation under the provisions of the laws of the State of Idaho, and do hereby adopt the following Articles of Incorporation, to-wit:

I.

The name of the corporation shall be "Westview Guernsey Dairy, Inc."

II.

The nature, objects and purposes for which this corporation is formed shall be:

- (a) To receive, handle, pack, store, distribute, sell, market and traffic in milk, cream and other raw and finished dairy products and by-products, of whatever kind; to process and manufacture butter, cheese, ice cream and other finished dairy products and by-products and otherwise deal in and with the same.
- (b) To establish, carry on and conduct, a processing, manufacturing and marketing business and agency, with adequate facilities, through which milk, cream and other dairy, ranch and farm products may be received, standardized, processed, prepared for market and marketed.
- (c) To engage in any activity in connection with the production, marketing, selling, harvesting, preserving, drying, processing, canning, packing, storing, handling or utilization of any and all agricultural products or the manufacturing or marketing of the by-products thereof;
- (d) To carry on and conduct a general mercantile business;
- (e) To buy, sell and deal in all kinds of contracts, notes, bills of sale, mortgages and other evidences of debt, and the security for the payment of the same; to buy and sell all forms of insurance and to act as an agent for insurance companies; to discount or negotiate notes, bills and other evidence of debt; to buy, sell, own and hold shares of capital stock of other corporations.
- (f) To acquire by purchase, subscription or otherwise, and to hold or hypothecate, or to dispose of stocks, bonds, or any other obligation of all kinds; and to sell, trade in and exchange the same, and all classes of stocks, bonds, notes, bills of sale and other securities;

- (g) To buy, hold purchase, sell, mortgage, lease or exchange real or personal property of all kinds.
- (h) To carry into effect the object and purpose aforesaid, this corporation is authorized to do all and singular the things necessary and convenient to carry out the general purposes for which it is organized.
- (i) All the foregoing provisions of this Article II are to be construed both as objects and powers, and it is hereby expressly provided that the enumeration herein of specific powers and objects shall not be held to limit or restrict in any manner the general purposes and powers of the corporation; provided, however, that nothing herein contained shall be deemed to authorize or permit the corporation to carry on any business or to exercise any power or do any act which a corporation formed under the laws of the State of Idaho now or hereafter existing may not, at the time, lawfully carry on or do. It is the intention that the purpose, objects and powers specified in each of the paragraphs of this Article II shall except as otherwise provided, in no wise be limited or restricted by reference to or inference from the terms of any other clause or paragraph in these Articles contained or of any other provisions of these Articles of Incorporation.

### III.

The duration of this corporation shall be perpetual.

### IV.

The location and post office address of the registered office of the corporation is and shall be 11 Canyon Street, Nampa, Canyon County, Idaho.

### V.

The total authorized number of shares which may be issued by this corporation is Five Hundred Shares of common stock with a par value of One Hundred and no/100 (\$100.00) Dollars per share.

### VI.

All shares of this corporation are the same class with equal rights and voting power and without preference or priority of any share over any other share.


