ARTICLES OF INCORPORATION FER 26 AM 10 21

The undersigned, acting as the incorporator of a corporation (hereinafter referred to as the "Corporation") organized pursuant to and subject to the Idaho Business Corporation Act; Chapter 1, Title 30, <u>Idaho Code</u>, as now existing or hereafter amended and supplemented (the "Act"), adopt the following Articles of Incorporation for the Corporation.

ARTICLE I. NAME

The name of the Corporation is HIGHLAND CONIFERS INTERNATIONAL, INC.

ARTICLE II. PERIOD OF DURATION

The period of duration of the Corporation is perpetual.

ARTICLE III. PURPOSES

The purposes for which the Corporation is organized are the transaction of any or all lawful business for which corporations may be incorporated under the Act; to do everything necessary, proper, advisable or convenient for the conduct of said business; and to do all other things incident thereto or connected therewith which are not forbidden by the Act, by other law or by these Articles of Incorporation.

ARTICLE IV. AUTHORIZED SHARES; RESTRICTIONS

The aggregate number of shares of capital stock which the Corporation shall have authority to issue is ONE HUNDRED THOUSAND (100,000) shares, of one class only. The par value of each share is one cent (\$0.01).

ARTICLE V. REGISTERED OFFICE AND AGENT

The address of the initial registered office of the Corporation is 3801 St. Andrews, Boise, Idaho 83705, and the name of its initial registered agent at that office is G. David MacGregor.
