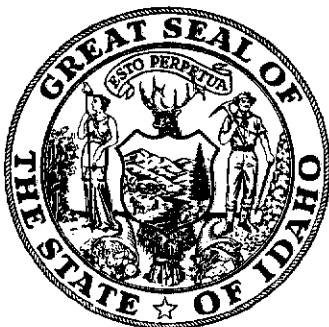

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

**FIRST:** The name of this corporation is CUB, Inc.

**SECOND:** The period of its duration is perpetual.

**THIRD:** The purpose or purposes for which the corporation is organized is the transaction of any and all other lawful business for which corporations may be incorporated within the State of Idaho.

**FOURTH:** Capital stock shall be TEN THOUSAND DOLLARS. The aggregate number of shares which the corporation shall have authority to issue is One Thousand (1,000) shares at a par value of ten dollars (\$10.00).

**FIFTH:** Provisions for the regulation of the internal affairs of the corporation are as governed by the By-Laws.

**SIXTH:** There shall be a restriction on the transfer of any interest whatsoever of the stock of this Corporation.

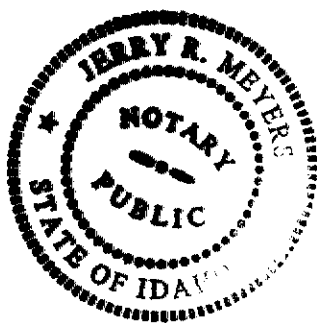
