That we, the undersigned, a majority of whom are free holders, citizens and residents of the State of Idaho, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, AND WE HEREBY CERTIFY:-

FIRST-. That the name of the corporation shall be the FAIRVIEW

CEMETARY COMPANY.

SECOND-. That the purposes for which it is formed are to have and to hold real and personal property; to care for and regulate the graves of the departed buried upon the lands held by said company; to decorate, regulate or otherwise care for the said graves or ornament the said graves as the company may desire from time to time and to do all other acts necessary to be done in order to fully care for and burty any of the dead.

THIRD-. The place where the principal business of said corpora

tion is to be carried on shall be Fairview, Oneida County, Idaho.

FOURTH-. That the term for which said corporation is to exist shall be fifty years from and after its incorporation.
