ARTICLES OF INCORPORATION OF IMAI, INC.

KNOW ALL PESONS BY THESE PRESENT, that we, the undersigned, each being a natural person of full age, and a citizen of the United States of America, have voluntarily and do hereby associate ourselves together for the purpose of forming a non-profit corporation under the laws of the State of Idaho, and we do hereby certify, declare and adopt the following Articles of Incorporation:

I

CORPORATE NAME

The name of this non-profit corporation shall be "IMAI, Inc."

II

EXISTENCE

The period of existence and duration of the life of this non-profit corporation shall be perpetual.

III

REGISTERED AGENT

The name, location and address of the registered agent and registered office of this non-profit corporation shall be Tracy Basterrechea: 1223 E Watertower Dr, Meridian, Idaho 83642.

The names and addresses of the initial Incorporators and Directors of this non-profit corporation are Steve Vierra, Tim Wilson, and Ivan Sim, at 1223 E Watertower Dr, Meridian, Idaho 83642. There are no voting members.

IV

PURPOSES

The nature of the business and the objectives and purposes of this non-profit corporation shall be exclusively for charitable and educational purposes under Section 501(c)(3) of the Internal Revenue Code, or any corresponding section of any future federal tax code.

V

DIRECTOR POWERS

In furtherance, and not in limitation of the powers conferred by statute, the Board of Directors is expressly authorized to exercise, conduct, manage and control the powers, business, affairs and property of the non-profit corporation, and to make such rules and regulations which are consistent with these Articles and the laws of the State of Idaho as they may deem best, all of which as set forth in the By-Laws of this non-profit corporation.

Any such assets not disposed of shall be disposed of by the Court of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

This non-profit corporation reserves the right to amend, alter, change or repeal any provisions contained in these Articles of Incorporation in the manner now or hereafter prescribed by statute, and all rights conferred upon the members herein are granted, subject to this reservation.
