## ARTICLES OF INCORPORATION

OF

The undersigned, acting as incorporators of a Corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such Corporation:

## ARTICLE I

### NAME

The name of the Corporation is TEXAS PACIFIC INVESTMENTS INC.

#### ARTICLE II

#### **PURPOSE**

The purpose or purposes for which the Corporation is organized is to transact all lawful business for which corporations may be organized under the Business Corporation Act of the State of Idaho.

## ARTICLE III

## DURATION

The Corporation shall have perpetual existence.

# ARTICLE IV

## SHARES

The total authorized stock of the Corporation is

1,000 shares of common stock, having a par value of \$1.00 per share.

#### ARTICLE V

## PREEMPTIVE RIGHTS

The shareholders of the Corporation shall have no preemptive rights, by virtue of Idaho Code §30-1-26, to buy, purchase or acquire stock issued or to be issued by the Corporation.

### ARTICLE VI
