ARTICLES OF INCORPORATION

OF

NORTHWEST MACHINE, INC.

KNOW ALL MEN BY THESE PRESENTS that we, AL E. BEAUCHENE and JANICE BEAUCHENE, husband and wife, and DICK H. WEATHERLY and JANETTE WEATHERLY, husband and wife, all of whom are of legal age, and have this day voluntarily associated ourselves together for the purpose of forming a corporation under and pursuant to the laws of the State of Idaho and we do thereby certify:

I.

That the name of this corporation shall be

NORTHWEST MACHINE, INC.

II.

That the duration and existence of this corporation shall be perpetual.

III.

That the purposes of this corporation as formed are as follows:

In addition to all of the corporate powers as provided by the statutes of the State of Idaho for general business corporations for profit or otherwise, this corporation shall be empowered to buy, sell, trade, repair and manufacture machinery

and equipment of every type or sort, buy, sell, trade, repair and manufacture parts and accessories for machinery and equipment of every sort, and to buy, sell, and trade supplies and implements of every kind and nature utilized in the repair and manufacture of machinery and equipment, parts and accessories therefor, and to do all acts permitted by the general business corporation law of Idaho and all such other legal acts as are necessary and expedient to accomplish these stated purposes.
