Know all men by These Presents: That we; the undersigned/ have
this day voluntarily associated ourselves together for the purpose
of forming a corporation, under the laws of the State of Idaho.

And we hereby certify:

First.

That the name of said corporation is The Idaho Socialist Publishin^g
Company, Limited.

Second.

That the purpose for which it is formed is to purchase the needed
machinery, type, buildings and tools for the carrying on of the
publication and circulation of Socialistic papers, pamphlets and
literature of all descriptions; book binding and job printing.

Third.

That the place where its principal business is to be conducted and
transacted shall be the City of Idaho Falls, Bingham County, Idaho.

Fourth.

That the term for which it is to exist is fifty years from and af-
ter the date of its incorporation.

Fifth.

That the number of its Directors shall be five, and that the names
and residences of those who are appointed to serve as such for the
first year are, as follows:-
