



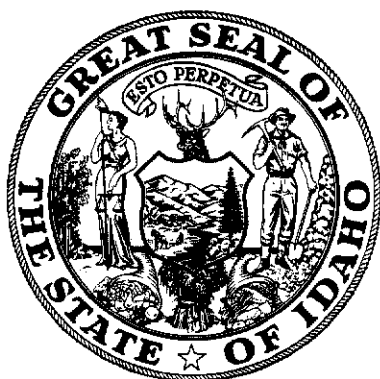
CERTIFICATE OF INCORPORATION

ARTICLE I

The name of this corporation is North Idaho Computer Service, Inc.

ARTICLE 2

This corporation has perpetual existence.

ARTICLE 3

The purpose or purposes for which this corporation is organized are:

- (1) Principally to provide computer and consulting and accounting services to individuals and business organizations.
- (2) To engage in any other lawful business or activity whatsoever which may hereafter from time to time be authorized by the Board of Directors.

ARTICLE 4

The address of the registered office of the corporation is 421 Coeur d'Alene Ave., Coeur d'Alene, ID 83864 and the name of the registered agent at such address is Curtis A. Clark.

ARTICLE 5

The total authorized number of par value shares of the corporation is Fifty Thousand (50,000) shares of the par value of One Dollar (\$1.00) per share, amounting in the aggregate to Fifty Thousand Dollars (\$50,000).

ARTICLE 6

The number of directors of this corporation shall be fixed in the manner specified by the bylaws of this corporation. The first directors of the corporation are two in number and their names and addresses are:

The first directors shall serve until the first annual meeting of shareholders and until their successors are elected and qualified.

ARTICLE 7

The name and address of the incorporator is:

ARTICLE 8

At each election for directors, every shareholder entitled to vote at such election has the right to vote in person or by proxy the number of shares of stock held by him for as many persons as there are directors to be elected. No cumulative voting for directors shall be permitted.

ARTICLE 9

(1) No contracts or other transactions between the corporation and any other corporation or entity, and no act of the corporation shall in any way be affected or invalidated by the fact that any of the directors of the corporation are pecuniarily or otherwise interested in, or are directors, officers, principals or agents of such other corporation or entity, and

(2) Any director individually, or any firm of which any director may be a member, may be a party to, or may be pecuniarily or otherwise interested in, any contracts or transactions of the corporation, provided that the fact that he or such firm is so interested shall be disclosed or shall have been known to the Board of Directors or a majority thereof.

ARTICLE 10

The corporation reserves the right to amend, alter, change or repeal any provision contained in these Articles of Incorporation, in the manner now or hereafter prescribed by law, and all rights and powers conferred herein on shareholders and directors are subject to this reserved power.

ARTICLE 11

The authority to adopt, alter, amend or repeal bylaws is hereby vested in the Board of Directors.
