## ARTICLES OF INCORPORATION

SECRETARY OF STATE Pursuant to the provision of the Idaho Non-Profit Corporation Act, the undersigned incorporators hereby form a corporation and the following are its Articles of Incorporation.

Article 1

The name of the corporation shall be Tiger Paus & Maws, Incorporated

Article 11

The purposes for which this Corporation is formed are:

The corporation shall have the power to sue and to be sued, to hold, receive, lease and purchase such real estate and personal property as may be requisite and expedient for its purpose, and to sell, lease, encumber and dispose of such property. It may adopt or amend by-laws, rules and regulations not inconsistent with applicable laws and these Articles. It shall have all other powers granted to non-stock, non-profit corporations by the general laws of this State. The Corporation shall not have or issue shares of stock or pay dividends, no part of its earnings or assets shall inure to the benefit of or be distributable to its members, directors, officers or other private person, except that it shall be authorized to pay reasonable compensation for services rendered and to make payments and distribution in furtherance of its purposes.

The Corporations's duration shall be perpetual. In the event of dissolution, after payment of all liabilities, its surplus shall be donated to a taxexempt organization as determined by the Board of Directors of the Corporation.

#### Article 111

The affairs of the Corporation shall be managed by a Board of Directors elected from the membership in the manner provided by the by-laws. The Board of Directors may be increased or decreased as provided by the bylaws, but in no case shall the number of directors be less than \_\_\_ The directors shall hold office for a term of \_\_\_\_\_\_ years, except as the by-laws may otherwise provide. The number of directors constituting the initial Board of Directors is three (3), and the names and addresses of the persons who are to serve as directors until the first annal meeting of the Corporation, or until their successors are duly elected and qualified, are as follows:
