Pursuant to the provisions of §30-1-61 of the Idaho Business Corporation Act, SCIENTECH, Inc. has adopted the following Articles of Amendment to its Articles of Incorporation:

I

The name of the corporation is SCIENTECH, Inc.

II

The following amendments of the Articles of Incorporation were adopted by the shareholders of the Corporation on October 12, 1995, in the manner prescribed by the Idaho Business Corporation Act:

RESOLVED, that Article V of the Articles of Incorporation of SCIENTECH, Inc. be amended to read as follows:

V

The business of this corporation shall be managed and conducted by a Board of Directors. A majority of the directors must be present at a meeting to constitute a quorum for the transaction of any business, and the act of the majority of the Directors present at a meeting at which a quorum is present shall be the act of the Board of Directors. Notwithstanding the foregoing provisions of this Article, so long as Lawrence J. Ybarrondo holds the largest single outstanding block of voting shares of the corporation and for a period not to exceed three years or the termination of the corporation's Small Business Administration's 8(a) contracts, whichever comes first, his act at a meeting at which a quorum is present shall be the act of the Board of Directors.
