ARTICLES OF INCORPORATION C.G. DONOHO & SON CONSTRUCTION, INC.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, all full age citizens of the United States of America, have this day voluntarily associated ourselves together for the purpose of forming a corporation under and pursuant to the laws of the State of Idaho, and we do hereby certify:

That the corporate name of this corporation shall be "C. G. DONOHO & SON CONSTRUCTION, INC.".

II.

That the purposes and objects for which said corporation are formed are as follows:

- (a) To operate and maintain sand and gravel production and sales business together with all attendant business and operations connected or associated therewith.
- (b) To operate and conduct a general construction business together with all attendant business and operations connected or associated therewith.
- To acquire, buy, own, hold, sell, exchange, let or lease personal property and real estate within the State of Idaho, or outside the State of Idaho, and to lend money for profit, and to make, hold and realize upon any property pledged or hypothecated for the payment thereof.
- To borrow money for the purposes of this corporation, to issue bonds, notes and debentures and other evidences of indebtedness therefor, and to secure the same by mortgage or pledge of personal property, including the income of said corporation, or by mortgage of real property, executed in trust or otherwise. or any portion of the real or personal property of the corporation may be so pledged, mortgaged or hypothecated.
- To build any or all buildings, structures, warehouses and stores and stations necessary or convenient for the conduct

of the business of said corporation, or to acquire the same by purchase, lease or otherwise.

- (f) To purchase, lease, or otherwise acquire, in whole or in part, the business, goodwill, rights, franchises and property of every kind, and to take over the whole or any part of the assets or liabilities of any person, firm, association or corporation engaged in or authorized to be conducted by this corporation, or owning property necessary or suitable for its purposes and to pay for the same in cash, in the stock or bonds of this corporation, or otherwise; to hold or in any manner dispose of the whole or any part of the business property so acquired, and to exercise all the powers necessary or incidental to the conduct of such business.
- To enter into any contract, cooperative agreement or 14 profit sharing plan with its officers or employees that the corporation may deem advantageous or expedient, or otherwise to reward or 16 pay such persons for their services as the directors may deem fit.
- (h) To purchase, or otherwise acquire, own, hold, mortgage, 18 pledge, sell, assign, transfer or otherwise dispose of shares of capital stock of this corporation or evidences of indebtedness of any kind or nature created by any corporation or corporations, wherever organized, whether public or private, including the right to participate in the forming of any new corporation that in anywise affects or is related to the major purposes of this corporation including the purchase of stock of any other corporation.
- To exercise generally the powers customarily exercised $26\|$ by business corporations, and particularly the powers provided by the laws of the State of Idaho, referring especially to Section 30-114, Idaho Code, in any State in the United States and throughout the world.
 - To carry on any other business, or to do anything in connection with the objects and purposes above mentioned that may be necessary and proper to accomplish successfully or promote the

said objects and purposes. The foregoing clauses, by reason of the specific enumeration of powers, shall not be held to restrict the powers of the corporation to do any of the things within the purview of its general purposes.

This corporation shall have perpetual existance.

The location and post office address of the registered office in this State and principal place of business shall be Route 1, Box 78, Payette, Payette County, Idaho.

v.

The authorized capital stock of this corporation shall be TWO HUNDRED FIFTY THOUSAND and NO/100 (\$250,000.00) DOLLARS, divded into 2,500 shares of capital stock at the par value of \$100.00 per share. Such shares of stock shall be entitled to one (1) vote on all matters, and no preference or restrictions are granted to or imposed upon said shares of stock except that such stock shall be non-assessable.

VI.

That the corporate powers of said corporation shall be vested in a board of directors, three in number, which shall be elected and chosen as set forth in the By-laws of this corporation.
