That pursuant to the provisions of Idaho Code, \$30-146, Salmon River Meadows Mutual Water Co., an Idaho corporation, in accordance with the statutes of the State of Idaho, and in accordance with its By-Laws does hereby amend its Articles of Incorporation as follows:

1. Article II(a) is hereby amended to read
 as follows:

"To associate its stockholders together for their mutual benefit and to that end, to engage in the business of providing domestic water service, by purchase, lease or otherwise. To engage in the business of delivery of domestic water to the owners of each lot in Salmon River Meadows and Salmon River Meadows Annex Subdivisions in Lemhi County, Idaho."
