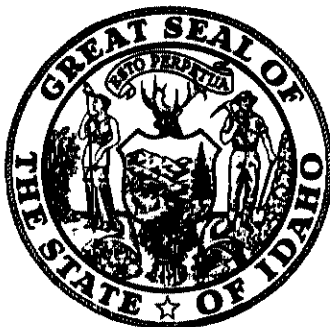

I, the undersigned, acting as incorporator of a corporation under the Idaho Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST

The name of the corporation is COMMUNITY HEALTH SERVICES HOME MEDICAL EQUIPMENT, INC.

SECOND

The location of the registered office of the corporation in the State of Idaho is 417 Indiana, Coeur d'Alene, Idaho 83814.

THIRD

The name of the registered agent of the corporation is LINDA CLOSE, the registered office of the corporation is 417 Indiana, Coeur d'Alene, Idaho 83814.

FOURTH

The period of its duration is perpetual.

FIFTH

The purpose or purposes for which the corporation is organized is health care related activities and the transaction of any or all other lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

SIXTH

The aggregate number of shares which the corporation shall have authority to issue is TEN THOUSAND (10,000) shares with par value of ONE AND NO/100 (\$1.00) DOLLAR per share.

SEVENTH

Any one or more of the Directors may be removed either with or without cause, at any time, by a vote of the stockholders holding a majority of the stock at any special meeting called for that purpose.
