Articles of Incorporation for: Camden Heights Home Owners Association, Inc.

Article 2: The purpose for which the corporation is organized is:

To provide an entity for the maintenance, preservation and control of the common areas within Camden Heights Subdivision, a subdivision in the city of Nampa, Canyon County, Idaho.
