ARTICLE I

The name of the corporation is Kids View, Inc.

ARTICLE II

The period of the corporation's duration is perpetual.

The purposes for which the corporation is organized are to transact any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act, including but not limited to the operation of a Day Care business.
