

Since the procedures prescribed by Sections 30-1-83, 30-1-84, 30-1-85, 30-1-86, 30-1-87 Idaho Code have been completed and duplicates will be made and verified by the signatures of the president, the secretary and a third officer of Christ's Church of Emmett, Idaho, Inc. Christ's Church of Emmett, Idaho, Inc. submits to the Office of the Secretary of State that the following articles have been completed.

- (c) Since Christ's Church of Emmett, Idaho, Inc. has always remitted its bills and debts for the current month and since no outstanding debt, fees, or bills remain on our books as of this date it was unnecessary that any creditors be notified.
- (d) As of this date, November 5, 1990, Christ's Church of Emmett, Idaho, Inc. has paid all its creditors and is not in debt to any established business or individual.
- (e) The remaining property and assets of Christ's Church of Emmett, Idaho, Inc. have been distributed in accordance with the distribution provision in the articles of incorporation and in keeping with the consent of the existing board and share holders in proportion with their respective rights and interests.
- (f) There are no suits, judgements, orders, or decrees pending in any court against Christ's Church of Emmett, Idaho, Inc.

(g) The dissolution of Christ's Church of Emmett, Idaho, Inc. has, as of November 5, 1990, received the unanimous written consent of the share holders by the following procedure as required by Section 30-1-84 Idaho Code.

- (1) The board of directors adopted a resolution recommending that Christ's Church of Emmett, Idaho, Inc. be dissolved and that the question of dissolution be submitted to a vote at a special meeting of the shareholders (members) on November 5, 1990.
- (2) Written notice was given to each shareholder entitled to vote with the purpose being to consider the advisability of dissolving Christ's Church of Emmett, Idaho, Inc.
- (3) A vote was taken at such meeting as to the advisability of dissolving Christ's Church of Emmett, Idaho, Inc. The result being that the motion to dissolve Christ's Church of Emmett, Idaho, Inc. was carried unanimously.
