



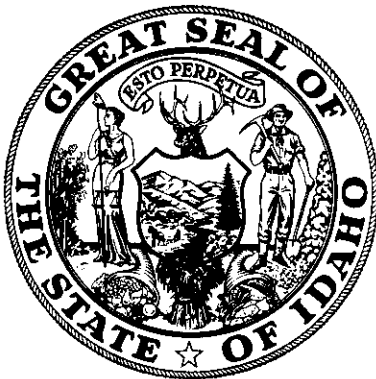
CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION

The undersigned incorporator(s), desiring to form a corporation pursuant to the provisions of the Idaho Business Corporation Act, adopt(s) the following articles of incorporation:

ARTICLE ONE. The name of the corporation is Harker & Son Inc.

ARTICLE TWO. The purposes of the corporation are diesel and mechanic repair and service, and to engage in any or all lawful business for which corporations may be organized under the Idaho Business Corporation Act or the purpose of the corporation is to engage in any or all lawful business for which corporations may be organized under the Idaho Business Corporation Act.

ARTICLE THREE. The period of duration of the corporation is perpetual.

ARTICLE FOUR. The address of the corporation's initial registered office in the State of Idaho is Rt. 1, Box 1640, Teton, Idaho, County of Teton, 83452. The name of the corporation's initial registered agent at such address is Gordon Harker.

ARTICLE FIVE. The total authorized number of no par value shares of stock is 300,000.

ARTICLES OF INCORPORATION

ARTICLE SIX. The shareholders of said corporation shall have the right to retain their proportionate ownership by reasonably exercising a right of first refusal to purchase any new issue of previously authorized stock.

ARTICLE SEVEN. The number of directors constituting the initial board of directors is three (3) and the names and addresses of the persons who are to serve as directors until the first annual meeting of the shareholders or until their successors are elected and qualify are:
