Article 1. Name

The name of the Corporation is **Dust Busters Janitorial Services, Inc.**

Article II. Period of Duration

The period of duration of the corporation is perpetual.

Article III. Purposes and Powers

Section 1. Section 2. Dividends. The holders of the common stock shall be entitled to receive, when and as declared by the Board of Directors, as permitted by the Act, dividends or distributions payable either in cash, in property, or in shares of the capital stock of the Corporation.

Section 3. Stock Nonassessable. The prive property of the shareholders of the Corporation shall not be subject to the payment of corporate debts to any extent whatsoever, and shares of the Corporation shall not be subject to assessment for the purpose of paying expenses, conducting business, or paying debts of the Corporation.

Section 4. Voting Power. The entire voting power for the election of the Directors and for all other purposes shall be vested exclusively in the holders of the common stock, who shall

be entitled to one vote for each share of common stock held by them record.

Article V. Preemptive Rights
