KNOW ALL MEN BY THESE PRESENTS: That We, the undersigned, natural persons of full age and citizens of the United States of America, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho.

We do hereby certify --

I.

That the name of the corporation is and shall be IRVIN CATTLE CO.

II.

That the duration of this corporation is perpetual.

III.

That the place of business of this corporation and home office location is Route #1, Box 302, Fruitland, Idaho.

IV.

That the purposes for which this corporation is formed are:

To purchase, own, improve, equip and manage farms and engage in any agricultural pursuit or undertaking including but not limited to the following:

To conduct and carry on the business of buying, selling, and dealing in all kinds of grain, hay, or other farm produce and farm products, livestock, and provisions, and all other kinds of goods, wares, and merchandise.

To buy, sell, mortgage and hypothecate any and all real and personal property.

To deal in any and all stocks, bonds, notes, and other evidence of debt. and.
