ARTICLES OF INCORPORATION

of the

"McDONALD MERCANTILE CO."

know all Men by these presents: That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation, and hereby do become a corporation, under the laws of the state of Washington, and adopt the following articles of incorporation.

ARTICLE I.

The name of this company shall be the "McDonald Mercantile Co."

ARTICLE II.

The purposes for which said corporation is formed are to carry on and conduct a general wholesale and retail mercantile business in any and all lines within the state of Washington, United States of America and elsewhere; to carry on and conduct a general wholesale and retail manufacturing and lumber business within said territory; to own, operate, buy, sell, lease, erect, or otherwise acquire, sawmills and factories for the manufacturing of lumber, wither in Yough or finished state, and for manufacturing or finishing all articles of trade made therefrom, and to own, buy, sell, lease, or otherwise acquire all machinery and appliances of every kind and description that may be necessary in connection therewith; to purchase, take on, lease or in exchange or otherwise acquire or hold lands, estates, buildings, rights of way, light or water or any other rights or privileges, machinery, businesses, good wills, plants, stock in trade, or other real or personal property that may be deemed necessary to carry out any of the objects of this company; to construct, maintain, improve, manage, work, control,

and superintend any trails, roads, tramways, railways, bridges, reservoirs, water courses, sawmills, hydraulic works, electrical works, or other works or conveniences which may seem conducive to any of the objects or purposes of the company; to use steam, water, electrical or any other power as a motive power, or otherwise; to purchase, acquire, hold, erect and operate electric light and other power plants for milling and manufacturing purposes, and for the purpose of furnishing lights and creating power; to bond, buy, lease, locate and hold ditches, flumes and water rights; to construct, lease, buy, sell, build or operate railroads, ferries, or tramways or other means of transportation for transporting logs, lumber of other material; to own, bond, buy, lease and locate, or otherwise acquire, timber and timber claims; to borrow money and secure the payment thereof in such manner as the company may see fit; finally to do everything consistent, proper and requisite for the carrying out of the objects and purposes aforesaid in their fullest and broadest extent, within said territory.

ARTICLE III.

The place where the principal business of said corporation shall be carried on shall be at the city of Spokane, Spokane county state of Washington, and the company may establish branch offices at such other places as the board of trustees may from time to time by resolution designate.

ARTICLE IV.

The term for which this corporation shall exist if fifty (50) years from and after the date of its incorporation.
