CERTIFICATE OF INCORPORATION

I, IRA H. MASTERS, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho, do hereby certify that the original of the articles of incorporation of

LIONS CLUB OF BURLEY, IDAHO, INC.

was filed in the office of the Secretary of State on the Fourth day of April A. D. One Thousand Nine Hundred Fifty-five and is duly recorded on Film No. 90 of Record of Domestic Corporations of the State of Idaho, and that the said articles contain the statement of facts required by Sections 30-103, 30-1101 and 30-1102, Idaho Code.

AND I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name stated in the articles, and for perpetual existence from the date hereof, with its registered office in this State located at Burley in the County of Cassia, and as such are subject to the rights, privileges and limitations granted to Religious, Ex-Service Men, Benevolent, Charitable and Fraternal Corporations, as provided in Chapter 11, Title 30, Idaho Code.

ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a non-profit corporation without capital stock under and pursuant to the laws of the State of Idaho, and we do hereby certify:

Article I

The name of this corporation shall be Linns Club of Burley, Idaho, Inc.

Article II

The purposes and abjects for which such corporation is formed are as follows:

1. To form a body of men thoroughly representative of the business and professional interests of the City of Burley, Idaho; to unite its members in the closest bonds of good fellowship and to promote a closer business and social union among them.
2. To encourage active participation in all things that have to do with commercial, civic, and industrial betterment.
3. To uphold the principles of good government.
4. To assist in every honorable way in furthering the interests of its members and towards bringing about a better understanding among men.
5. To teach that organization, co-operation, and reciprocity are better than rivalry, strife and destrictive competition.
6. To encourage the application of the highest ethical standards in business, and endeavor, by the exchange of methods and ideas, to increase efficiency in all lines represented.

Article III

This corporation shall have perpetual existence.

Article IV

The location and Pose Office address of this corporation shall be Burley, County of Cassia, State of Idaho.

Article V

This corporation is a non-profit corporation and shall have no capital stock and shall pay no dividends or salaries to its incorporators, officers or members of the board of directors.

Article VI

This corporation shall be and the same is hereby affiliated with the International Association of Lions Clubs and is subject to the constitution and the by-laws of that body insofar as they affect and prescribe the functions of this organization and are not in conflict with the statutes of the State of Idaho and these articles.

Article VII

The board of directors of this corporation shall consist of its officers and its elected directors, but in no instance shall the number be less than three or more than thirty-five members on the board. The government, membership, and officers, meetings and elections shall be as prescribed by the Constitution and By-Laws of the said corporation.

Article IX

Pursuant to a notice published in the Burley Herald, a newspaper published in the City of Burley, County of Cassia, for two weeks and posted at the National Hotel, Burley, Idaho, the place of the meeting, for a like period, an election of officers and board of directors of Lions Club of Burley, Idaho, Inc. was held on the 11th day of February, 1955, at the National Hotel at Burley, Idaho at the hour of 12:05 P.M. A majority of all members were present at such meeting and voted at such election and the result of such election was as follows:
