ARTICLES OF AMENDMENT
DECREASING CAPITAL STOCK OF
WYATT & KIPPER ENGINEERS, INC.

Articles of Amendment of the Articles of Incorporation of WYATT & KIPPER ENGINEERS, INC. are herein executed by said corporation, pursuant to the provisions of Revised Code of Washington 23A.16.040 and 23A.16.050, as follows:

1. The name of the corporation is WYATT & KIPPER ENGINEERS, INC.
2. The amendment to the Articles of Incorporation of said corporation is as follows:

"ARTICLE III.

"Capital Stock

"The authorized capital of this corporation shall consist of \$250,000.00 divided into 125,000 shares of voting common capital stock with a par value of \$2.00 per share."

3. The date of the adoption of said amendment by the shareholders of said corporation is April 4, 1972.

4. The number of shares outstanding of said corporation is 62,500 shares, all of one class.

The number of shares entitled to vote on said amendment was 62,500.

5. The number of shares voted for and against said amendment, respectively, were as follows:

For Amendment: 62,500 shares

Against Amendment: -0- shares

6. The manner in which said amendment provides for cancellation of issued shares of said corporation is as follows:

Decreasing the capital stock of the corporation by reducing the aggregate number of authorized shares of said voting common capital stock from the 250,000 shares previously authorized to 125,000. 62,500 of said shares, previously issued, were reacquired

by the corporation by purchase and were cancelled by the corporation on April 4, 1972, by action of the Board of Directors pursuant to the provisions of R.C.W. 23A.16.110.

7. The manner in which said amendment effects a change in the amount of stated capital of said corporation is as follows:

The stated capital of the corporation is reduced from \$250,000.00 to \$125,000.00.

The amount of stated capital as changed by said amendment is \$125,000.00.
