ARTICLES OF INCORPORATION OF

SPORTS MARKETING, INC.

I, the undersigned natural person of the age of eighteen years or more, acting as incorporator of a corporation under the Montana Business Corporation Act, adopt the following Articles of Incorporation for such corporation.

FIRST: The name of the corporation is SPORTS MARKETING, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are:

- (a) To establish, purchase, lease as lessee, or otherwise acquire, own, operate, and maintain, sell, mortgage, deed in trust, lease as lessor, and otherwise dispose of retail stores or departments therein; to buy, sell, trade, manufacture, deal in and with goods, wares, and merchandise of every kind and nature, and to carry on such business as wholesalers, retailers, importers, and exporters; to acquire all such merchandise, supplies, materials, and other articles as shall be necessary or incidental to such business; and to have any and all powers to carry out the purposes above iset forth as fully as natural persons, whether as principals, agents, trustees; or otherwise.
- (b) To engage in any other business for which a Montana corporation may be organized.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 50,000 shares of no par value.

FIFTH: Provisions limiting or denying to shareholders the preemptive right to acquire additional or treasury shares of the corporation are: NONE.

SIXTH: Provisions for the regulation of the internal affairs of the corporation are: NONE.

SEVENTH: The address of the initial registered office of the corporation is 235 Moore Lane, Billings, Montana 59101, and the name of its initial registered agent at such address is Harold Sutton.

EIGHTH: The number of directors constituting the initial board of directors of the corporation is two and the names and addresses of the

persons who are to serve as directors until the first annual meeting of shareholders or until their successors are elected and shall qualify are:
