ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION OF
STATE
TENDOY GIRLS' CAMP DIRECTORS, INC.

Pursuant to the provisions 30-326 Idaho Code, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the Corporation is Tendoy's Girls' Camp Directors, Incorporated.

SECOND: The following amendments of the Articles of Incorporation were adopted by the Directors of the Corporation on the 19th day of March, 1980, in the manner prescribed by the Non-profit Corporations Act contained in 30-301 et seq. Idaho Code:

Article II of the Corporation's Articles shall be amended to include Sections 5, 6, 7 & 8 as follows:

Section 5. This Corporation is organized exclusively for charitable or educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

Section 6. Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code.

Section 7. Upon the winding up and dissolution of this Corporation, after paying or adequately providing for the debts and obligations of the organization, the remaining assets shall be distributed to a non-profit fund, foundation or corporation which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code.

Section 8. This organization is not organized for profit, and no part of the net earnings shall accrue to the benefit of any private shareholder.

THIRD: There are no shares of stock in the Corporation and no membership certificates outstanding. The Corporation is run by the Board of Directors. On the 19th day of March, 1980, the Board of Directors of the Corporation considered the foregoing amendments and duly passed the same by resolution in favor of such amendments unanimously.
