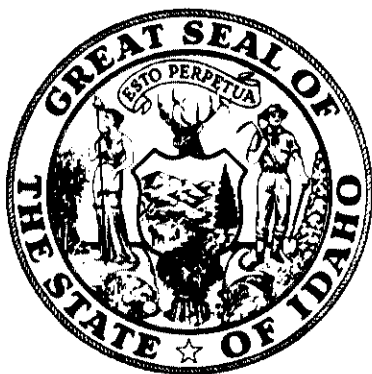

ARTICLES OF AMENDMENT TO  
ARTICLES OF INCORPORATION  
OF  
SPECTRAGRAPHS, INC.

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to the Articles of Incorporation dated January 17, 1991:

FIRST: The present name of the corporation is Spectra-  
Graphics, Inc., an Idaho corporation.

SECOND: The following Amendment to the Articles of Incorporation was adopted by the Shareholders of the corporation on October 1, 1991, in the manner prescribed by the Idaho Business Corporation Act:

Paragraph FIRST of the Articles of Incorporation of Spectra-  
Graphics, Inc. is deleted in its entirety and the following is  
substituted in its place.

FIRST

The name of the corporation shall be Spectra Printing and  
Graphics, Inc., an Idaho corporation.

THIRD: The number of votes of the corporation outstanding and  
entitled to vote on this Amendment is 2,000.

**FOURTH:** All of the shares of the corporation outstanding and entitled to vote as a class were common stock and no other class of stock existed.

**FIFTH:** 2,000 shares were voted in favor of the above stated Amendment and no shares were voted against it.


**SIXTH:** There will not be any exchange, reclassification or cancellation of shares by virtue of the foregoing Amendment.

**SEVENTH:** The stated capital of the corporation shall not change by virtue of the foregoing Amendment.


