#### ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF SNAKE RIVER BEAN COMPANY

Pursuant to the provisions of the Idaho Business Corporation Act, SNAKE RIVER

Articles of Amendment to its Articles of Incorporation:
