citizens of the State of Idaho, desiring to associate themselves for the purpose of forming a corporation under the provisions of Chapter 14 of TITUS 4 of the Mevised Codes of the State of Idaho, relating to the incorporation of Religious, Social and Benevolent corporations, do hereby certify:

FIRST.

That the name of this corporation shall be TATE HUKABE SOCIETY.

SHOOND.

That the purposes for which, the corporation is formed are: to promote and carry on such movements as may be proper to bring about a more stringent enforcement of the laws of the State of Idaho, relating to cruelty to animals; to provide for the care at animals and disposal of lost and abandoned animals; to provide for the care of animals left without proper feed, drink, or shelter from the weather; to sid in procuring evidence against violators of the laws of the State of Idaho, relating to cruelty to animals, and report such violations to the proper officers of the State, and furnish aid in the prosecution thereof; to educate in the proper care of animals, and promote a general higher regard for the lives and comfort of animals; to discourage the willful or unnecessary destruction of of wild animals and birds, and generally do any and all things necessary or incidental to the carrying out of the purposes of the corporation.

THIRD.

That the place where the principal business of the corporation is to be transacted is at Boise, Ada County, State of Idaho.

FOURTH.

That the term for which the corporation is to exist is fifty years from and after the date of its incorporation.

The Board of Directors shall be divided into three classes by such method as the Board may adopt at their first meeting after the incorporation of this Dociety. The first class shall hold office for the period of one year; the second class shall hold office for the period of two years; and the third class shall hold office for the period of three years, and three members of the mount of Directors shall be elected annually thereafter at each annual meeting of the members of this Society, and shall hold their office for the term of three years and until their successors are duly elected.

SIXTH.

Any person within this State shall be eligible to membership in this Society upon making application therefor and paying dues as shall be in the by-laws of said Society provided. Rembership shall consist of two classes to be known as contributing members and life members. The contributing members shall pay such sum as annual dues, as the by-laws shall provide to be payable at and in the manner in by-laws provided. Life members shall pay such sum for life membership as may be provided in the by-laws. Life members shall not be subject to any further dues or assessments. The liability of all members life and contributing shall be limited to the payment of annual dues or fees for life membership, and such members shall not be liable for any further assessments or for any claims against the Society.
