KNOW ALL MEN BY THESE PRESENT:

That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho.

And hereby certify:

ARTICLE I - NAME

The name by which this corporation shall be known is:

THE ACTS CHURCH, INCORPORATED

The principle place of business is located in the city of:

Lewiston County: Nez Perce State: Idaho

ARTICLE II - MEMBERSHIP

Any person accepting the doctrine of the Bible, Old and New Testament, in theory and in practice, may become a member by complying with the requirements relating to membership set forth in the by-laws of this corporation.

ARTICLE III - OBJECTS AND PURPOSES

The purpose for which this corporation is formed shall be:
to establish a non-prpfit organization under the Law of the State of Idaho for the purpose of:

1. To establish, further, nurture and extend the Kingdom of God in the minds and hearts of its own people, among the unchurched people, and, through active support of missionary, educational and charitable efforts, to help spread the Kingdom of God "to the ends of the earth" (Matt. 28:19-20). To promote and encourage and maintain good works by the cooperative efforts of men who believe the Gospel of the Grace of God as preached by Jesus Christ.
2. To assist in the organization, establishment, and maintenance of local groups of people who are believers in this Gospel.
3. To attain the purpose by the publication of Christian Literature of any and all kinds.
4. To ordain ministers to the work of this Gospel, in accordance with the by-laws of this corporation. Each candidate for this ordination must qualify scripturally according to I Tim. 3:1-7 and Titus 1:5-9.
5. To foster, develop and disseminate religious, moral and educational Christian teachings in Harmony with the Holy Scriptures, and, in particular as found in John 3:5-6; Matt 28:19-20; Acts 2:38-41; Acts 2:4; Acts 9:17; Acts 10:45-46; John 21:15-17; Acts 20:17,28,35; James 5:14-15; and Acts 6:1-7.
6. To further the establishment and operation in this Country or any other Country, of Christian missions and/or schools, including Vocational and Bible Schools.
7. To glorify the One True God, as revealed in Jesus Christ, Who is "The Way, the Truth and the Life" (John 14:16; John 1:1-4,14)
8. By any and all means of modern facilities to disseminate this Gospel.

ARTICLE IV - POWERS

This corporation shall have such powers as are provided by law, and including: to hold, sell, purchase, build, and/or construct suitable buildings for its accomodations to be devoted to and used for the purposes set forth herein above, and for the practical operation of this corporation; and to receive, and to hold in trust, or otherwise, funds received by gifts, bequests, or devise to be devoted to or used by it for such purposes. This corporation shall also have power to issue its promissory notes, bonds, or other obligations, to be secured by mortgages on its real property and other property, in such manner as may be provided by its by-laws.

ARTICLE V - MANAGEMENT

The management of this corporation, spiritual, religious, educational and temporal shall rest in its Pastor, Elders and Deacons. Any vacancy in office shall be filled according to the procedures set forth in the by-laws of this corporation.

ARTICLE VI - DURATION

The duration of this corporation shall be:

ARTICLE VII - DISSOLUTION

This corporation is organized pursuant to the General Non-Profit Corporation Law of the State of Idaho.

The property of this corporation is irrevocably dedicated to religious and charitable purposes and upon liquidation, dissolution or abandonment, after all financial liabilities have been paid in full, all the assets shall be distributed to an organization, foundation or fund, organized and operated for religious or charitable purposes and qualified for tax exemption purposes according to the National Tax Exemption Code.

ARTICLE VIII - SEAL

This corporation shall have a common Seal.

ARTICLE IX
REGISTERED OFFICE - REGISTERED AGENT
