ARTICLES OF AMENDMENT

of

YAMAMOTO AGENCY, INC.

WHEREAS, there was issued by the Secretary of State of the State of Idaho, a certificate of incorporation dated the 10th day of March, 1950, constituting and creating "Carlton Insurance Agency, Inc.", a corporation, under the laws of the State of Idaho, for perpetual existence, with its registered office in the State of Idaho located at Caldwell, in the County of Canyon,

And, WHEREAS, there was issued by the Secretary of State of Idaho, a certificate of Articles of Amendment dated May 27, 1950, certifying the change of name of said corporation, changing its corporate name to Carlton-Yamamoto Agency, Inc., all other provisions of the articles of said corporation at that time remaining the same,

And, WHEREAS, there was issued by the Secretary of State of the State of Idaho, a certificate of Articles of Amendment dated July 31, 1957, certifying the change of name of said corporation, changing its corporate name to Yamamoto Agency, Inc., and making certain other changes in the corporate articles as therein specified,

And, WHEREAS, the undersigned being all the officers and shareholders of said Yamamoto Agency, Inc. and also being all the shareholders entitled to vote and having been called upon notice, the receipt of which is hereby acknowledged by all of said persons, of the purpose of the meeting as being to consider the amendment of the articles of incorporation of said corporation, do hereby give their individual written consent to the amendment of the articles of incorporation so that the following numbered articles in the original articles and the amendments thereto will be amended to read as hereinafter set

forth, any articles not specifically listed to be and remain the same as previously set forth:

I.

The name of this corporation shall be Coff-Yamamoto Agency, Inc..

V.

The total authorized number of par value shares is Two Thousand (2,000). The aggregate par value of the total authorized number of par value shares is One Hundred Thousand (\$100,000.00) dollars.

VI.


