

RE: Use of “credit union or any derivation thereof” in Company Name in Idaho

Dear Ms. Stamm:

The Idaho Department of Finance (Department) received your email of December 12, 2023, requesting an approval letter to file with the Idaho Secretary of State to register and use the business name “Publix Employees FCU Inc. (PEFCU)” in Idaho. We understand that PEFCU is a federally chartered credit union (Charter # 23020), has branches in Florida and Georgia, is a Florida non-profit corporation, and will soon have one employee working remotely from Idaho.

Section 26-2107 of the Idaho Credit Union Act prohibits “[a]ny person, corporation, copartnership or association, except a credit union organized under the provisions of this chapter ... [or] the federal credit union act” (emphasis added) from “advertising or otherwise conducting business as a credit union” or using as part of its company name the words “credit union or any derivation thereof.” As a federally chartered credit union, PEFCU fits within the exception found in Section 26-2107. Therefore, the Department offers “no objection” to the use in Idaho of the name “Publix Employees FCU Inc.” and its registration with the Idaho Secretary of State as a foreign business entity.
