We, the undersigned, desiring to form a nonprofit corporation under the statutes of the State of Idaho, do hereby make, subscribe and acknowledge as follows:

ARTICLE ONE

## PURPOSE

The name of the corporation is Meridian Kiwanis Youth Foundation, Inc.

#### ARTICLE TWO

#### PURPOSE

The purpose of the organization is encouraging, promoting, and fostering the health, education, and welfare of young people living in the community of Meridian, Idaho and the surrounding vicinity.

#### ARTICLE THREE

## NONPROFIT PURPOSE

corporation is organized exclusively for religious, charitable, scientific, literary, or educational purposes within the meaning of section 501(c)(3) of the Internal Revenue Code. Notwithstanding any other provisions of these By-laws, the corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal Income Tax under section 501(c)(3) of the Internal Revenue Code. The Corporation is formed exclusively for purposes which are not for profit, and not for pecuniary profit or financial gain. No part of the corporate assets, income or profits shall be distributable to, or inure to the benefit of its officers; directors or members, except to the extent permitted for a nonprofit corporation under the nonprofit corporation laws of the State of Idaho and section 501(c)(3) of the Internal Revenue Code. The corporation shall not take steps which serve to facilitate the transaction of specific business by its officers, directors, or members; or promote the private interest of any officer, director or member; or engage in any activity which would constitute a regular business of a kind ordinarily carried on for profit.
