

**ARTICLES OF INCORPORATION**  
**OF THE WEISER CREAMERY COMPANY, ( LIMITED.)**

KNOW All Men By These Presents: That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a Corporation, under the laws of the State of Idaho.

And we hereby certify: First. That the name of said Corporation is The Weiser Creamery Company, ( Limited.)

Second. That the purposes for which it is formed are to receive or purchase milk or cream from its stockholders and other persons, and to manufacture and sell the products of milk.

Third. That the place where its principal business is to be transacted shall be the town of Weiser, in Washington County, State of Idaho.

Fourth. That the term for which it is to exist is fifty years from and after its date of incorporation.

Fifth. That the number of its Directors shall be five, and that the names and residences of those who are appointed for the first year are:
