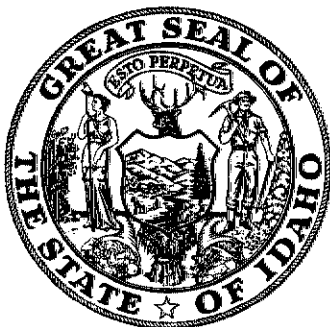
### CERTIFICATE OF AMENDMENT OF

## ARTICLES OF AMENDMENT

Pursuant to the provisions of 30-327 of the Idaho Nonprofit Corporation Act, the following Articles of Amendment to Articles of Incorporation are hereby submitted for filing.

ARTICLE 1. The name of record of the corporation is:

IDAHO COUNCIL ON INDUSTRY AND THE ENVIRONMENT, INC.

ARTICLE 2. The amendment is an amendment to Article I of the Articles of Incorporation relating to the name of the corporation and the amended article as adopted reads as follows:

### ARTICLE I.

Name

The name of the corporation is IDAHOANS FOR FOOD AND FIBER, INC.

ARTICLE 3. The date of the meeting of members at which the amendment was adopted was October 13, 1992. A quorum was present, and the amendment received at least a majority of the votes which the members present in person or by proxy were entitled to cast.
