

KNOW ALL MEN BY THESE PRESENTS: That I, the undersigned, in order to form a corporation, pursuant to the laws of the State of Idaho, do hereby certify as follows:

ARTICLE I

The name of this corporation shall be PIZZA HUT OF COEUR D'ALENE, INC.

ARTICLE II

The period of existence and duration of the life of this corporation shall be perpetual.

ARTICLE III

This corporation is formed to carry out any lawful purpose and shall have all the powers allowed by the laws of the State of Idaho.

ARTICLE IV

The capital stock of this corporation shall be divided into 8,000 shares of non-assessable common stock without par value.

ARTICLE V

The principal place of business of this corporation shall be in the City of Coeur D'Alene, County of Kootenai, State of Idaho. Thomas L. Gotschall is the registered agent and the address of the registered office of this corporation is 212 West Apple Way, Coeur D'Alene, Idaho 83814.

ARTICLE VI

The name and post office address of the incorporator is Thomas L. Gotschall, 212 West Apple Way, Coeur D'Alene, Idaho 83814.

ARTICLE VII

The management of this corporation shall be vested in a board of not less than one director and a maximum number as may be fixed by the Bylaws. Other than the first director of the corporation, the directors shall be elected at the annual meeting of the stockholders to be held at a time and place designated by the Bylaws. The first director of this corporation is:

ARTICLE VIII
